The purpose of the hearing is to consider the following resolution: The Town Board of the Town of Cape Vincent proposes to dissolve the Cape Vincent Fire Protection District as required for the establishment of the Cape Vincent joint fire district. The proposed dissolution shall become effective upon the effective date of the Cape Vincent joint fire district. The Town Board may meet immediately following the public hearing to vote on the proposal. Full text of the proposed plan for the dissolution of the Cape Vincent Fire Protection District is available at the Town Clerk's Office.

Any persons requiring special accommodations to attend and participate in such Hearing shall notify the Town Clerk at least three (3) business days prior to the date and time of the public hearing.

DESCRIPTIVE SUMMARY OF DISSOLUTION PLAN

THE TOWN BOARD PROPOSES TO DISSOLVE THE CAPE VINCENT FIRE PROTECTION DISTRICT AS PART OF THE PROCESS TO CREATE A JOINT FIRE DISTRICT WHICH WILL PROTECT THE VILLAGE OF CAPE VINCENT AND THE ENTIRE TOWN OF CAPE VINCENT. THE FIRE PROTECTION DISTRICT HAS NO ASSETS, LIABILITIES OR EMPLOYEES AND THERE ARE NO COSTS RELATED TO THE DISSOLUTION. THE DISSOLUTION WILL ONLY HAPPEN IF THE TOWN AND VILLAGE CREATE A JOINT FIRE DISTRICT. THE RESIDENTS OF THE CAPE VINCENT FIRE PROTECTION DISTRICT AREA WILL CONTINUE TO BE PROVIDED FIRE PROTECTION BY THE CAPE VINCENT FIRE DEPARTMENT, AS PART OF THE JOINT FIRE DISTRICT, JUST AS THEY ARE NOW. THE TOWN OF CAPE VINCENT WILL HOLD A PUBLIC HEARING ON THE PROPOSED PLAN ON THE 18th DAY OF August, 2016, AT THE CAPE VINCENT RECREATION PARK BUILDING, LOCATED ON JAMES STREET IN THE VILLAGE OF CAPE VINCENT, WHICH SHALL COMMENCE AT 6:45 PM TO TAKE COMMENT FROM INTERESTED PERSONS AND

THE PROPOSED DISSOLUTION WILL BECOME EFFECTIVE AT THE SAME TIME THAT THE JOINT FIRE DISTRICT BECOMES EFFECTIVE. THE PROPOSED DISSOLUTION PLAN MAY BE EXAMINED AT THE TOWN OF CAPE VINCENT TOWN HALL AT 1964 NYS ROUTE 12E, CAPE VINCENT, NY 13618.
