The Board then reviewed the minutes of the March 14, 2023 regular Board meeting and Trustee Ewing made the motion to accept them as written with Trustee Stark seconding the motion and all voting yes.

Attendee Silke Ernisse then addressed the Board with her concern about the safety of one of the large buildings at Anchor Marina that has a large piece of metal has been blown away from the building and hazardous. Trustee Stark stated that she will be in contact with ZEO Higgins to address the concern. The Board also agreed with the concern for safety.

Marty Mason, DPW Superintendent, then gave his report as follows:

- Travis Docteur has submitted his resignation letter as he has secured a position with Watertown
 City Fire Department. Also, James Johnson has returned from the 2-week water school, and he
 passed all tests. He will now go on the weekend rotations.
- The 3rd filter is complete and is back together. The paint will need 10 days to cure. The crew will get it going after that 10-day period and get it ready to get back online.
- The snow equipment is being cleaned up and getting ready to store for the season.
- The crew has done a little work at the Library and will be replacing some lights. Also at the Pavilion, the new can lights have been ordered and will be installed once received. The pavilion will be opened once the temperatures remain above freezing. There was a short discussion about the upcoming season at the pavilion to include parking.
- The crew will begin the brush and compost collecting next week.
- The crew will also be working on a "sinkhole" on Joseph St and a pipe will have to go under the road to correct the issue.

Shaun Cuddeback, OIC, then gave his report as follows:

- The tile work on the garage has begun.

Deputy Mayor Youngs, the addressed "old" business as follows:

- Lot on James St.: Marty has heard from Mark Gebo, who has made some progress with this situation and looks to have it wrapped up soon and we will hear more once he returns from vacation.
